There are no minimum net worth and no direct investment requirements under this program. Under the program, candidates have the provision to obtain assistance, financial support and knowledge in launching their enterprise from private sector organizations in Canada.

- If applying under designated Canadian venture capital fund, the investment must be obtained at least CAD 200,000.
- Applying under angel investor group, it should be at least CAD 75,000.
- Under Business Incubator, applicants do not need to secure any investment. However, they must be accepted into a Canadian business incubator program.
- Must acquire the Letter of Support from one of the aforementioned Canadian Designated Authorities
- Total 5 applicants can apply as a group for the Canada Start-up Visa
- You must have a qualifying business with each applicant hold more than 10% or more of the voting rights to all shares of the business
- The applicants and Canadian Designated Body together hold more than 50% voting rights to all the shares

## United Kingdom START-UP visa



UK start-up visa program was introduced replacing the Tier 1 (Graduate Entrepreneur) route in order to attract the global talent from around the world. The program aims to create a platform where business professionals with innovative business ideas can drive growth by increasing the levels of productivity and generating high-paid employment opportunities for residents.

- Your business establishment idea must be endorsed by UK Authorized body (UK higher education institution or UK business organization)
- There is no need to invest in the initial stage
- Must clear the English language proficiency examination (IELTS for UKVI / Life Skills) with CEFR level B2 (equivalent to IELTS 5.5 to 6 bands)
- Must demonstrate the proof of funds with minimum EUR 945 (INR 90,000 approx.) in your bank account which must be maintained for 90 consecutive days prior to application.

## Denmark START-UP visa



Launched in 2015, Denmark Start-up visa is one of the best startup program in Europe to attain the permanent residency and great business environment. If you have an innovative business idea, then you may consider Denmark for business immigration. Your business proposal will be evaluated by expert panel on the basis of innovative level of the business model, scalability of the business, capability of the team and business viability in the market. The permanent residency permit is granted initially for 2 which can be further extended for 3 years after demonstrating successful business venture.

- Business plan must be approved by Denmark Business Authority's Panel of Experts
- Must play an active contribution in the daily running of the business
- Proof of funds will be required:
  - 138,648 DKK for Single Applicant
  - 277,296 DKK for self and spouse
  - 322,908 DKK For Self, spouse and one or more children

## New Zealand START-UP visa - (NZ entrepreneur work visa)



New Zealand's Startup Visa is a unique pathway for the eligible Business professionals who wish to establish their business or buy an existing company in New Zealand. An alternate to Australia, New Zealand is equally self-sufficient and progressive in terms of economy, infrastructure, business environment and abundance of skilled professionals.

- Minimum Investment should be NZD 100,000 (excluding working capital).
- Must attain the score of 120 points or more on Work Visa Points System which will be assessed by the success of the business and its value to NZ.
- Must demonstrate a proper Business Plan for NZ.
- Meet the character, health and English language requirements.

## Italy START-UP visa



Who wouldn't want to immigrate to Italy? Perhaps, being one of the best countries in Europe, it has its own advantages in trade and business. Migrating to this beautiful would have difficult with the Entrepreneur Visa, but with the inception of Italy Startup Visa, the process became easy and smooth to attain the residency in Italy. - Minimum initial funding of EUR 75,000 (Funding can be your own or can be obtained from Angel investor or venture capital funding)
- Within 4 years, you must have the potential to generate minimum 10 new jobs in Ireland
- Must generate the revenue of minimum EUR 1,000,000 within 4 years
