

FINANCIAL ASSISTANCE APPLICATION









Application for financial assistance to Paralympic, Deaflympics or Special Olympics Athletes who form part of a sport association/organisation and will be representing Malta and Gozo in a foreign sports competition, during the year of 2019.

Introduction:

The Parliamentary Secretariat for Persons with Disability and Active Ageing will be dedicating a sum of €20,000 in order to aid and financially assist persons with disability in their preparation for a foreign sports competition during the year 2019.

The Parliamentary Secretariat for Persons with Disability and Active Ageing reserves the right to accept or otherwise the applications submitted, both for Section A and for Section B.

Section A:

The maximum financial aid that can be provided is the following:

- The maximum of €50 for the buying of shoes;
- The maximum of €100 for the buying of sportswear; and
- The maximum of €100 for the buying of sports equipment.

The total amount of financial aid that each applicant can benefit from, from this section is €250.

The payable amount is 85% or the maximum amount of the indicated threshold for each category of Section A will be paid after presentation of fiscal and original receipts by the applicant, following the approval of the Parliamentary Secretariat for Persons with Disability and Active Ageing.

An applicant who would like to benefit from the financial assistance listed in Section A have to present:

- A copy of this application; and
- Fiscal and original receipt(s).

The above are to be submitted physically to the Parliamentary Secretariat for Persons with Disability and Active Ageing, Palazzo Ferreria, Republic Street, Valletta, or through electronic mail on financialassistance.psdaa@gov.mt till 1st November 2019.

Section B:

Pier Diem Financial Assistance

Each applicant participating in a foreign sports competition can benefit from a *pier diem* of \leq 20 per day, up to a maximum of 10 days, that is, the maximum of \leq 200 per participant.

The applicant has to present a copy of their boarding pass to the sports competition and the return boarding pass from the sports competition.

Participation Fee Financial Assistance

The applicant also has the option to opt for financial assistance with regards to the participation fee of the foreign sports competition. In this case, the applicant has to provide proof of the competition fee that he or she would have individually paid. If the applicant has not benefitted from the pier diem financial assistance listed in this section, the maximum of financial assistance with regards to the competition fee is €200 per participant.

If the athlete is going to benefit from the per diem financial assistance and also from the participation fee financial assistance, the total amount of financial assistance that the applicant can benefit from, from Section B is €200 per participant.

The applicant has to submit the application to the Parliamentary Secretariat for Persons with Disability and Active Ageing, Palazzo Ferreria, Republic Street, Valletta, or electronically on financialassistance.psdaa@gov.mt by 1st November 2019.
